No work will be accepted after the receiving period. If you cannot make these times, please find a friend or family member to bring your work.

Sales: **Artists may have their work for sale, or not, as they choose. Sanchez Art Center, as the artist's representative, will retain a 30% commission on any work sold. Sold work will remain in place for the duration of the exhibit, and no work may be removed before 5 pm Sunday, July 9. Work "Not for Sale" shall be marked NFS.

- ☐ Work is ready to hang with picture **wire and screw eyes or D-rings. SORRY, NO SAW-TOOTH HANGERS ACCEPTED.**
- ☐ Work is no more than 48" wide. Work weighs 20 lbs. or less. (3D piece must fit on one pedestal.)
- ☐ Work is original and not previously shown in a Sanchez Art Center or Art Guild of Pacifica exhibition.
- ☐ Work is dry and labeled (artist, title, medium, price or NFS) on the back (or underneath for 3D work).
- ☐ Multiple entries from each artist will be accepted only on space available basis.
(If a diptych or triptych, work is framed as one piece, or considered as multiple entries.)
- ☐ \$20 entry fee (check, cash or PayPal) or two gallery attending vouchers per entry. \$30 for non-members.
- ☐ DUES & ENTRY FEES MAY BE PAID AT RECEIVING WITH CASH, CHECK, OR PAYPAL.
- ☐ **Exception to any above guideline has been approved in advance by gallery committee member:** (_____)
