**Artists are responsible for managing their own sales.**

Artists will also be responsible for hanging their work at their assigned location.

- No commission charged. Nameplate on the wall & chair provided will be provided.
- Narrow table allowed (max. width approximately 24 inches from wall).
- Artist is responsible for hanging and pricing their own art, AGP will supply art hanging hardware.
- **Bonus: *One artwork in Winter Art Faire Small Works at no charge.***

## Terms & Conditions:

1. All of the goods that I will sell at WAF will be handmade by me.
2. **Participant agrees to open their booth on time (11 AM) and stay open until end of each day (5 pm).**
3. Participant will not sell (or encourage) weapons or drug paraphernalia and will not use any lead in items that are meant for food.
4. Participant understands that if for any reason I cancel or fail to appear, **participant will not receive a refund.**
5. Participant will abide by the policies of the Sanchez Art Center including San Mateo County Covid-19 health and safety protocols, fire codes, parking, business license and insurance regulations.
6. Participant will not park a vehicle at the front parking area except while actively loading or unloading and will remove their vehicle before unpacking.
7. Participant will not have any fire in their space and will not put anything in the space between designated spaces.
8. Participant will not sublet booth space; nor sell someone else's work.
9. If participant sell any products not included on the product list in application, participant understands they will be asked to remove items and may be asked to leave the event without refund.
11. AGP will provide the participant one chair at their wall space.
10. If participant will break any of the agreed upon conditions they may be asked to leave (without refund) and/or be banned from future participation.
11. Items made with once living products (shells, insects, fur, etc.) will need to be discussed in advance of your application being approved in order to understand how items were sourced. Items not ethically or sustainably sourced will not be accepted.
12. In San Mateo County the use of single-use plastic bags has been banned as have plastic straws in Pacifica.
13. Items for this show should be politically neutral and are encouraged to be positive and in the spirit of the holidays and gift giving.
14. **We ask that you do not post any signs stating that a portion of your sales will go to a certain cause. While you are allowed to donate to causes you care about, Sanchez Art Center is a non-profit and they commit to ethical practices by being transparent with financial information and fundraising practices. We are unable to support solicitation for other organizations.**

## Participating Artist/Artisan Agreement:

I understand that all visual artists and artisans, wishing to participate as a vendor will have their artwork juried for acceptance. The fee to participate \$50 unless noted otherwise. Quality and originality are the prime criteria. Only original artwork will be considered. No kits, imports, resale or manufactured items will be accepted. My entire display will fit on the wall space assigned. I understand that electricity is not available but the gallery will be lighted. **Early breakdown is not permitted and I will be present during all the hours listed**, breakdown must be finished by 6pm on Sunday. I will promote this event to friends, family, mailing lists, on social media, email, and/or pass out cards inviting others. I have read the above requirements and agree to abide by them.
