Open to everyone, this Art Guild exhibition is not juried, but is themed. "Lost in the Weeds" may include any artwork about or interpretation of the phrase. Artwork must meet the requirements of the checklist below to be in the show.

Exhibition Coordinators: West Gallery Committee will arrange the show and have final say in the placement of artwork. For information contact: agp.artguild@gmail.com or (650) 355-1894.

Sales: Sanchez Art Center, as the artist's representative, will retain a 30% commission on any work sold. Sold artwork will remain in place for the duration of the exhibit, and no artwork will be removed before 5 pm on Sunday, March 23. Artwork "Not for Sale" shall be marked NFS.

All entered artwork must be signed out and removed from Sanchez Art Center by noon, Mon, March 24. Artists not picking up their artwork must notify Sanchez Art Center staff ahead of time and may be charged \$10/day. Artwork not picked up after thirty days becomes property of Sanchez Art Center. To make arrangements for pickup outside the scheduled return, contact Sanchez Art Center staff (650) 355-1894 before March 23.

Artwork must meet the guidelines listed below. Please check off boxes below and submit with artwork.

- Work is ready to hang with picture **wire and screw eyes or D-rings**.
Wire and hardware must be secure and in good condition. NO SAW-TOOTH HANGERS ACCEPTED.
- Work is no more than 48" wide. Work weighs 20 lbs. or less. (A 3D piece must fit on one pedestal.)
- Framed flat work must be safely mounted in an appropriate size frame. Matboard, frame and glass must be clean and free of blemishes.
- Work is original and not previously shown in any Sanchez Art Center or Art Guild of Pacifica exhibition.
- Work is dry and labeled (artist, title, medium, price or NFS) on the back (or underneath for 3D work).
- Multiple entries from each artist will be accepted only on a space available basis. (If a diptych or triptych, work is framed as one piece; otherwise it is considered as multiple entries.)
- \$20 entry fee - check payable to Art Guild of Pacifica or cash, or 2 gallery attending vouchers per entry.
\$30 entry fee for non-members.
- I acknowledge that my artwork may be photographed for the purpose of promotion on AGP/SAC website and/or AGP/SAC social media sites.
- Exception to any above guideline has been approved before receiving by a West Gallery committee member
